The Food and Drug Administration and the Center for Disease Control have established a link between I-tryptophan and a sometimes fatal blood disorder called eosinophilia-myalgia syndrome which is marked by severe muscle and joint pain, swelling of the arms and legs, skin rash, and sometimes fever. It is characterized by severe eosinophillia, a blood disorder in which the white blood cells increase to an abnormally high level. I-Tryptophan occurs naturally in many foods and investigation has not established whether it or an impurity introduced during manufacture or distribution is the cause.

To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

No toxic effects are to be expected when the product is handled appropriately.
